Associations expressed his gratitude to all the members of Yoga Federation of India for their cooperation in making the activities of Yoga Federation of India successful. He requested Smt. Indu Aggarwal, President, YFI to preside over the meeting of YFI.

Smt. Indu Aggarwal, President, YFI while extending warm welcome to all the members present in the meeting conveyed her thanks to the Officer Bearers, YFI, officials of Punjab Yoga Association, Presidents / Secretaries State / UT Yoga Associations, National Yoga Referees and yoga players from different states of India for their cooperation to make 47th Sub-Junior & Junior National Yogasana Sports Championship at Ferozepur (Punjab) a grand success.

The meeting came into order as per agenda:-

Following points were discussed as per agenda of the meeting.

1. 47th Senior National Yogasana Sports Championship at Tamil Nadu.

It was informed by the President, YFI that in the Annual General Meeting of YFI held on 28th October, 2022 at Ferozepur (Punjab), the 47th Senior National Yogasana Sports Championship was allotted to Tamil Nadu Yogasana Association. She further informed that Yogiraj N. Ramalingam, Secretary, Tamil Nadu Yogasana Association is making all his efforts to fix the venue & dates of the said championship in Tamil Nadu State. As soon as the dates & venue of the championship are fixed & informed by the host the same will be circulated to all the States/ UTs Yoga Associations. She requested all the Presidents / Secretaries to send the entry of their respective State/UT Yoga Association by the last date of entry positively to facilitate the host to provide all facilities to the participating teams.

2. Senior State Yogasana Sports Championship.

It was further informed by the President, YFI that the States/UT Yoga Associations who have still not conducted their Senior State Yogasana Sports Championship must conduct the same immediately so that a good team from their state can participate in the 47th Senior National Yogasana Sports championship.

3. Player Registration

It was requested by the President, YFI that the Secretaries, State/UT Yoga Associations must send immediately the complete data of players of senior groups in the Google link given below so that the I-card of the players can be prepared well in time.

4. National Yoga Referee's Diploma/Up-gradation Examination- (Online)

The President, YFI informed that Yoga Federation of India has so far 1713 National Yoga Referees registered with it. To further increase the strength of its technical officials from all over the country, the Yoga Federation of India is planning to conduct National Yoga Referee's Diploma Examination/ Up-gradation Examination-Online on **25th December, 2022**. She requested all the Presidents / Secretaries to forward the names of the eligible candidates for the said examination by 5th December, 2022.

5. National Yoga Referee's Refresher Course - (Online)

The President, YFI informed that Yoga Federation of India has been conducting the National Yoga Referees Refresher Courses from time to time to technically update its technical officials. She requested the secretaries to forwards the names of only those

National Yoga Referees for 47th Senior National Yogasana Sports championship who are technically expert and can attend all the workshops / refresher courses being conducted by YFI. This time also the National Yoga Referees Refresher Course will be conducted online before the organization of 47th Senior National Yogasana Sports championship.

The members present in the house gave unanimous approval for the above said proposals.

6. Court Case of YFI.

The President, YFI requested Shri Ashok Kumar Aggarwal, Chairman, YFI to inform the house regarding the latest position of court case of YFI.

Shri Ashok Kumar Aggarwal, Chairman, YFI informed the house that last date of court was on 04.11.2022. But as the petitioner Shri Yash Parashar has given the application to withdraw the case of YFI but with the timely intervention, the learned counsel of the petitioner, Advocate Shri Devvrat, prayed for and was granted liberty to withdraw the said application. Accordingly the application was dismissed as withdrawn dated 28th October, 2022. Taking the advantage of this withdrawal, the respondent made the plea in the court that they should be given more time to file their reply. The next date of court hearing is 20th March, 2023. The federation will try its best to get early hearing in this case.

As there was no other business to transact, the meeting came to end with vote of thanks to the chair.
